  - Attach proof of current First Aid
    - Photocopies of front & back of current card
  - OR
  - Copy of course roster reflecting your attendance
  - Enclose check or money order made payable to WVDOF

  - VA Licensed Loggers: Provided a copy of your current Sharp Logger card (front & back)
